



## TRANSIT SAFETY OFFICER (Talent Pool)

**Metrolinx** is an agency of the Government of Ontario and our goal is to create a transportation network that enhances the prosperity, sustainability and quality of life for the Greater Toronto and Hamilton Area. It leads the planning in the region with its Regional Transportation Plan that guides the work and investments of the organization. It builds light transit, bus rapid transit and Regional Express Rail and operates GO Transit, UP Express and PRESTO.

Our Transit Safety Office is seeking applications to create a talent pool for the position of Transit Safety Officer. Transit Safety Officers protect the safety and security of passengers, employees and property and to maintain the integrity of the fare system.

### **Key Responsibilities:**

- Ensures consistent and non-discriminatory enforcement of provincial and federal statutes and bylaws pertaining to the general conduct of patrons, fare inspections, liquor offences, and parking control. May issue appropriate offence notices, summonses or appearance notices to individuals for non-compliance. Executes warrants when appropriate.
- Providing assistance and protection to Metrolinx patrons and their property, employees and corporate assets and ensuring the appropriate action is taken.
- Promoting and maintaining excellent customer relations.
- Responds to passenger assist alarms on moving equipment as well as station/facility alarms and performs such duties as crowd control, searching of Metrolinx premises, protecting site or evidence, obtaining statements from witnesses, providing first aid and/or assistance to passengers, employees and emergency services.
- Maintaining operating protocol with railway and regional police services within all jurisdictions serviced by GO Transit; and maintaining the public peace within the Metrolinx transit system.
- Interpreting and applying various legislation including; Metrolinx By-laws, The Criminal Code and other related federal and provincial statutes, on or in relation to Metrolinx property.

**Location:** Various locations and shifts within the Greater Toronto Area.  
Must be prepared to work on a 24-hour rotating shift basis (including days, evenings, weekends and holidays).

### **Qualifications:**

- Knowledge of law enforcement principles and practices normally attained through completion of a two (2) year community college program in law enforcement and/or equivalent law enforcement experience.
- Minimum six (6) months' experience directly involving law enforcement activities with exposure to police and court services
- Ability to interpret and apply the Criminal Code, the Metrolinx Act 2006, the Liquor Licence Act, the Trespass to Property Act, The Mental Health Act, the Highway Traffic Act, and other related federal and provincial statutes.

- Experience in customer service and/or previous or current commitment to community involvement would be considered an asset.
- Strong interpersonal, oral and written communication skills. Bilingual abilities would be considered an asset.
- Ability to make frequent decisions in the field under potentially harmful and stressful conditions.
- Must be able to pass an Ontario Provincial Police (O.P.P.) security clearance as well as a background investigation (which includes education, employment, personal history, credit and reference checks) for the purpose of obtaining Special Constable Status, and to access the C.P.I.C and P.A.R.I.S information systems and uphold the Special Constable Code of Conduct.
- Must be able to pass the Basic Special Constable recruitment training program and must be able to obtain: Metrolinx Equipment Operator's Permit, First Aid Certification, CPR Certification, & Pressure Point Control Tactics (PPCT) Certification.
- Valid Ontario Class "G" drivers licence with no more than 4 demerit points.
- Must successfully complete environmental, safety and any other training required by corporate policy.

**Note:** Work may involve encountering confrontational situations. This position requires extended periods of walking, standing, climbing stairs and regular operation of departmental vehicles over long distances for prolonged periods of time.

**All applicants are required to have a valid Applicant Testing Services (ATS) Special Constable Test Result Profile at the time of application (and remain valid throughout the recruitment process).
